Prospect Process

- Each prospect will be required to complete the BURN Ryder application in full, including copies of drivers license, motorcycle registration, and proof of insurance coverage.
- Prospect will be interviewed by the Club President and Chapter President
- Pending their approval Prospect will start a 90 day probationary period during the standard riding season which they must participate in at least 75% of scheduled BURN Motorcycle Club events.
- Failure to follow the club bylaws during the probationary period may result in loss of Prospect status.
- Upon successful completion of the probationary period, the Prospect will be awarded BURN Ryder status by the Club President.
